Dunnville Master Servicing Plan Update

Haldimand County has initiated a Municipal Class Environmental Assessment (MCEA) to update the Master Servicing Plan (MSP) prepared in 2009 for the community of Dunnville.

HOW WILL THIS AFFECT ME?

The purpose of this study is to update the four servicing components of the 2009 Dunnville MSP (water, wastewater, stormwater, and transportation) to reflect updated land use and growth forecasts in the study area. The updated MSP will guide future infrastructure projects in the community.

The proposed infrastructure alternatives may have an impact on stakeholders, rightsholders, and property owners, therefore, consultation will be a key element of the process and input will be sought throughout the study.
